## RELEASE AND WAIVER OF LEGAL LIABILITY

The undersigned's acceptance of and agreement to this Release is an express condition of your use of the Golf Course. In signing this agreement, the undersigned expressly acknowledges that the undersigned's use of and activities on the Golf Course may be hazardous and may involve risks, including but not limited to bodily injury or property damage. The undersigned further acknowledges that in agreeing to execute this Release, he or she is voluntarily and expressly assuming all of the risks, known or unknown, associated with and incidental to such use of the Golf Course and is agreeing to follow any rules set for the use of the Golf Course or set by Willsboro Golf LLC or its shareholders, owners, members, directors, managers, officers, agents, employees, successors or assigns, and/or others acting on their behalf (collectively, "Willsboro Golf LLC") in connection with the Golf Course. The undersigned hereby agrees to release, waive, forever discharge and relinquish Willsboro Golf LLC from and agree to indemnify and hold harmless Willsboro Golf LLC from any and all action or cause of action, suit, demands, claims, damages, attorneys' fees, known or unknown, for all present and future claims and liabilities of any kind that may arise or have arisen in connection with the use of the Golf Course and facilities of Willsboro Golf LLC, regardless of whether such claim shall arise by the negligence or unintentional conduct of Willsboro Golf LLC. This Waiver shall be governed in all respects by the laws of the State of New York.

In signing this Waiver, the undersigned further acknowledges that his or her agreement to the terms of this Release is made in exchange for good and adequate consideration, and that such consideration is adequate in light of the contents of this Release. The undersigned also acknowledges in signing this Release that he or she is fully aware of the legal import of signing this Release, has consulted legal counsel and is competent to enter into this Release. I hereby authorize any representative of Willsboro Golf LLC to arrange to treat the undersigned for injury in any medical emergency during use of the Golf Course. Further, I agree to pay all costs incurred for medical care and transportation for the undersigned, as the case may be. I represent that the undersigned has no known medical/health problems that would be affected by his or her use of the Golf Course.

**GENERAL RELEASE, INDEMNIFICATION AND HOLD HARMLESS:** I hereby agree for myself and my respective heirs, assigns and legal representatives, to indemnify, defend and hold Willsboro Golf LLC harmless from any and all claims and causes of action of any nature for any and all personal injury or illness, including death, or property damage which may occur to me during, or arising from my use of Willsboro Golf Course.

**ASSUMPTION OF RISK:** I expressly and specifically assume any and all risk of injury, illness, death, or property damage resulting from use of Willsboro Golf Course, further understanding that Willsboro Golf LLC does not have a lightning detection system or other means to warn me of adverse weather conditions. **Once you sign, you are saying that you understand and acknowledge the risks involved and hereby agree to accept all of the risks.**
